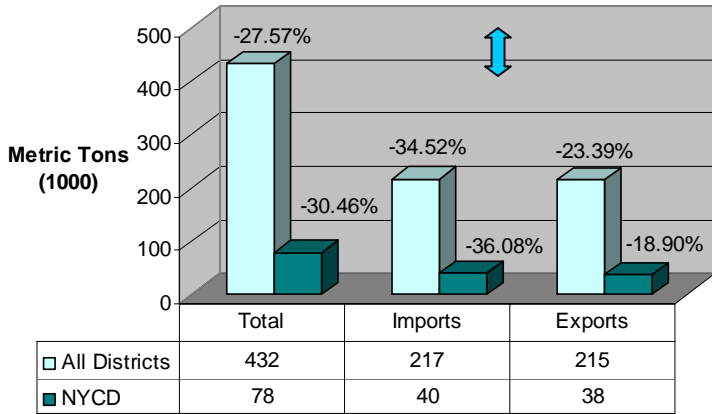

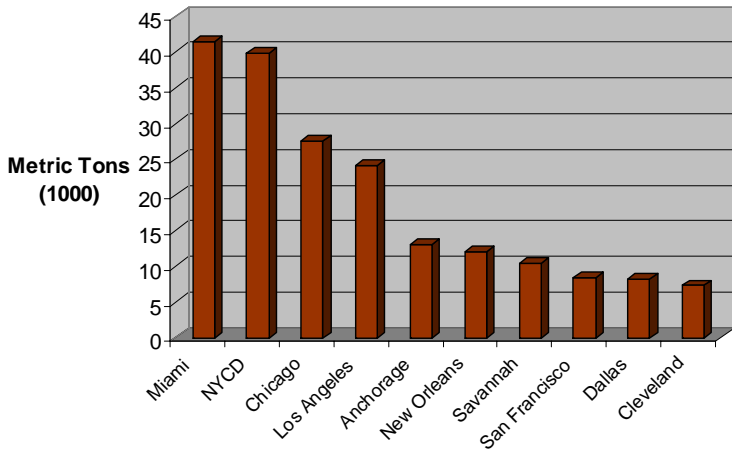

### NYCD compared to Nation (January 2009)

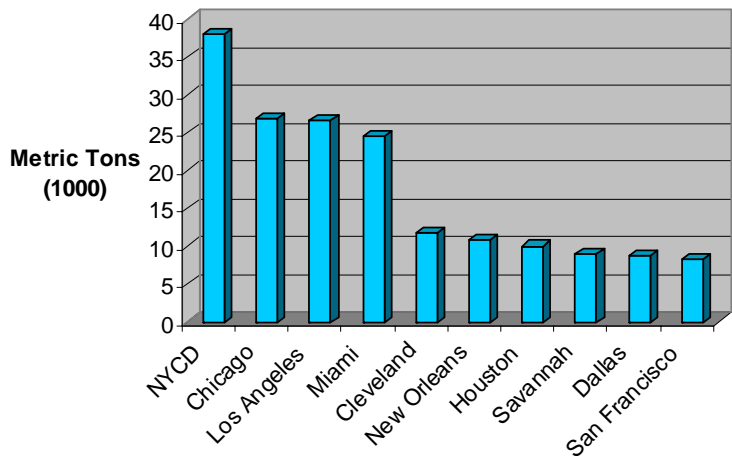
Year over Year Percent Change

### January 2009

- The New York Custom District (NYCD) continues to rank as the largest District in the United States in terms of total tons via air traffic for the January 2009 period. The NYCD fell to number two for imports while remaining the number one U.S. Customs District for Exports.
- Total air cargo trade** through the New York Custom District (NYCD) for the January 2009 period has declined by -30.46%. The nation's growth for the January 2009 period experienced declines of -27.57%. The NYCD represented 18.0% of the nation's total trade by weight.
- YTD NYCD **imports** declined by -36.08% while the nation's total imports also experienced similar declines of -34.52%. Decreases in machinery and Wearing Apparel commodities were drivers of January's declines. The NYCD represented 18.4% of total U.S. import trade. See pages 3 & 4 for the commodity details of NYCD trade.
- January **exports** had a decrease of -18.9% versus January 2008, which was less than the nation's decrease of -23.39%. The NYCD had a 17.7% market share of the nation's export traffic.

### Import Traffic

January 2009 imports were weak versus the same monthly period of 2008 with 40 thousand metric tons moving into the region. Commodity-wise, all top ten import commodities experienced negative growth in January. See page 3 & 4 for commodity details.

**JFK** represented 15.2% market share and ranked 2nd place.  
**EWR** represented 3.2% market share and ranked 10th place.

### Export Traffic

40 thousand metric tons were exported from the NYCD in January 2009. All top ten commodities except Fish & Seafood showed negative growth. See pages 3 & 4 for commodity details.

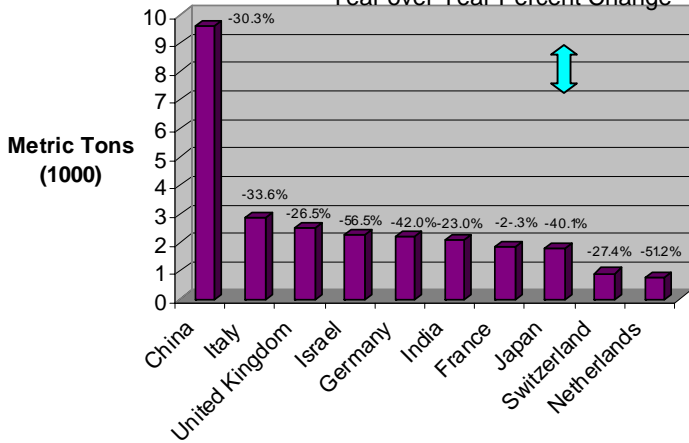

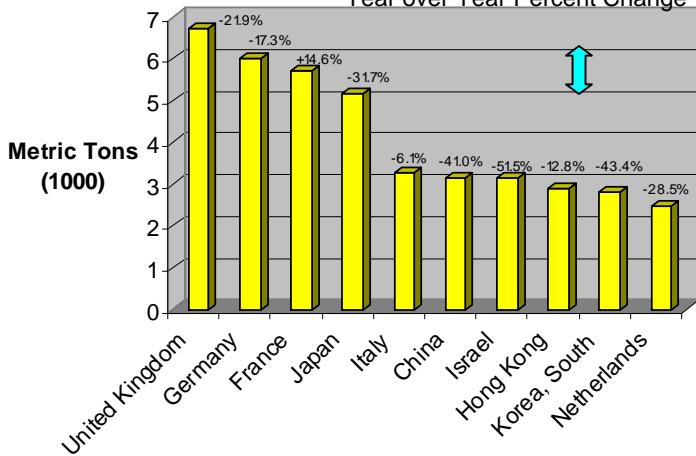
### Top Ten Countries Importing via NYCD

#### Import Trade

- China was the top import trade partner of the NYCD. Although China tonnage was down -30.34% vs. January 2008, market share grew slightly to 24.1%, more than three times higher than number two trade partner Italy. Top commodities from China were Woven & Knit Apparel and Machinery & Electrical Machinery.
- European nations Italy, U.K., and Germany were numbers 2, 3 & 5 respectively, all showing double-digit negative growth. Footwear from Italy was down. The UK had strong growth in Machinery while Germany had declines in Machinery.
- India imports to the NYCD fell by -23.0% versus January of 2008, led by Wearing Apparel declines.
- Number four Israel had -56.5% negative growth. Pharmaceutical Products and Electrical Machinery had significant negative growth while Vegetables gained +31.9%.
- The top ten NYCD import trade partners represented 67.2% of all NYCD imports.

#### Export Trade

- Nine out of the top ten NYCD trade partners showed negative growth in January 2009.
- The UK was the NYCD's top export trade partner. Although Machinery commodities were significantly down, Pharmaceutical, Optical & Medical Instruments, Iron & Steel, and Plastic commodities all experienced solid growth.
- Other European countries Germany France & Italy finished 2,3, & 5 respectively. France was the only top ten trade partner to show positive growth (+23.3%). Number 4 Japan was the only Asian country in the top five.
- The top ten trade partners to the NYCD represented 54.4% of all exports.

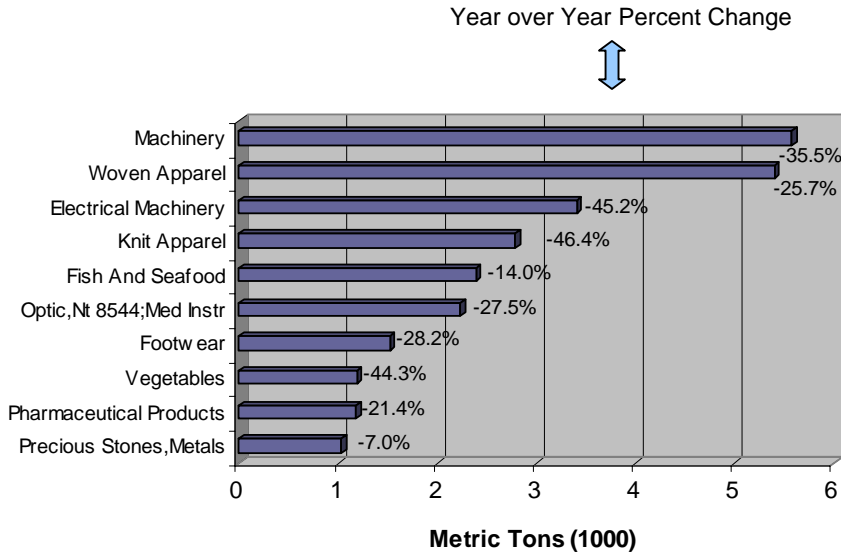

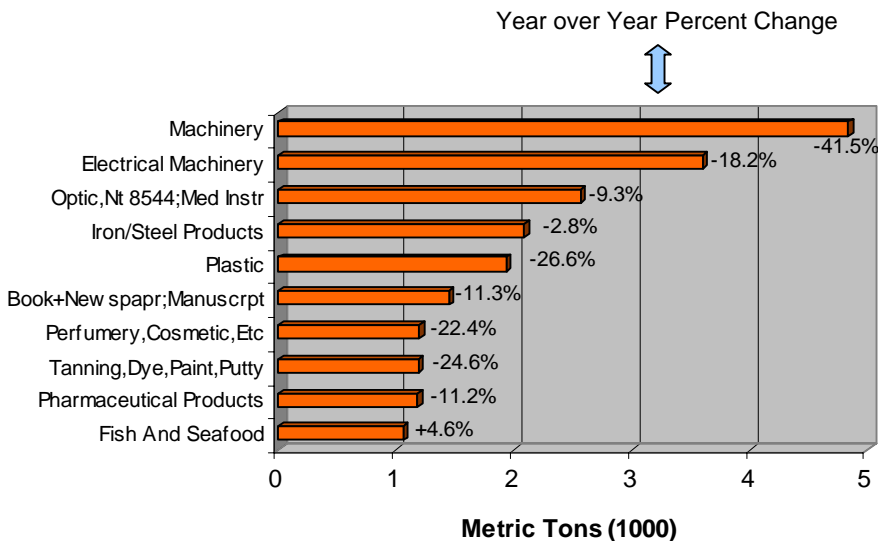
## Top Ten NYCD Imported Commodities (January 2009)



## Imported Commodities

- Machinery and Woven Apparel remain as the top two NYCD import commodities. Electrical Machinery, Knit Apparel, and Fish & Seafood respectively round out the top five commodities. Number 8 commodity Vegetables showed significant declines of -44.3% versus January of 2008.
- Organic & Inorganic Chemicals, Stone, Plaster, Cement, and Arms & Ammunition were the only top twenty commodities to exhibit positive growth. Perfume & Cosmetics and Plastic commodities experienced nearly -50% decreases in January.
- Vehicles showed an -89.6% decrease and Paper & Paperboard had a -45.0% decline.
- The top ten import commodities represented 66.9% of total NYCD import traffic in January 2009.

## Top Ten NYCD Exported Commodities (January 2009)

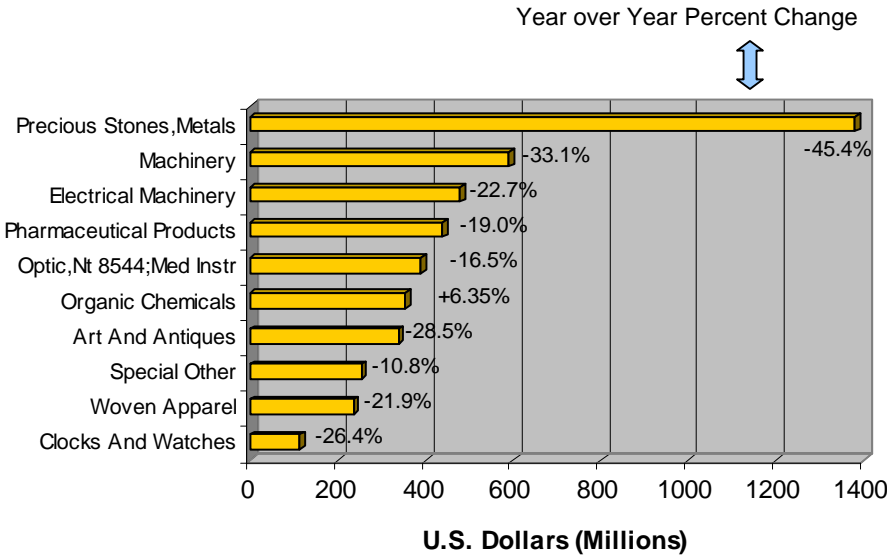


## Exported Commodities

- The NYCD's top ten export commodities represented 55.5% of total exports transported in January 2009.
- All top ten export commodities had negative growth except for Fish & Seafood, which had +4.6% growth versus January 2008. Number one commodity Machinery had the largest declines with -41.5% negative growth.
- Civilian Aircraft Parts and Photographic Film & Processing Supplies both showed solid gains in January.
- Meat and Explosives commodities both experienced more than +1000% growth.

# Commodities by Value January 2009

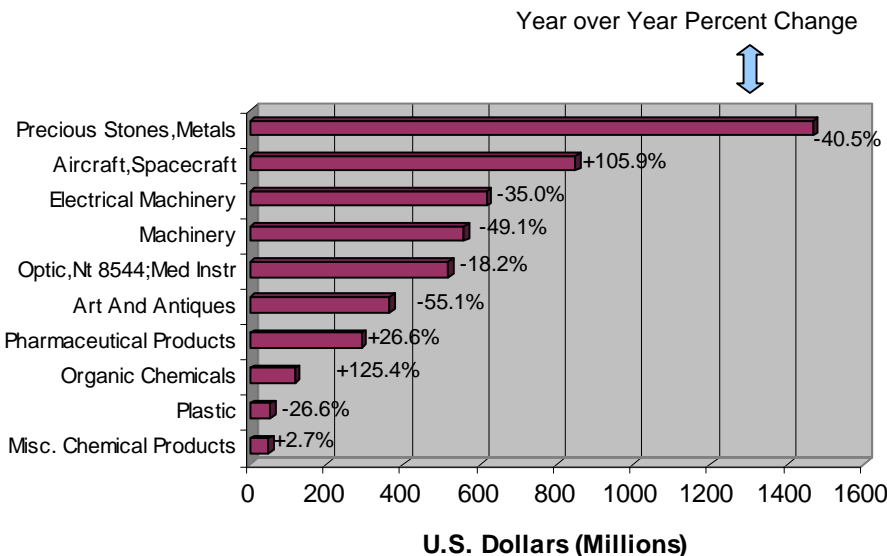
## Top Ten NYCD Imported Commodities (January 2009)



## Imported Commodities

- Precious Stones & Metals continue to be the leading commodity by value of the NYCD, representing more than a quarter of the total value of commodities imported through the NYCD. Precious Stones & Metals was down -45.4% versus January 2008.
- Organic Chemicals was the only top ten commodity by value to show positive growth in January 2009.
- 23 out of the top 25 commodities displayed significant double-digit negative growth.
- The top ten commodities represented 88.8% of the total value of commodities imported into the NYCD.

## Exported Commodities

- The NYCD's top ten exports by value represented 91.6% of the January 2009 NYCD exported trade.
- Precious Stones & Metals remained as the number one export commodity by value for the NYCD with a 27.55% market share.
- Number two commodity Aircraft Parts experienced +105.9% growth. Number three Electrical Machinery and number four Machinery had double-digit declines of -35.0% and -49.1% respectively.
- Number seven Pharmaceuticals experienced solid +26.6% growth and number eight Organic Chemicals had significant +125.4% growth.
