To prospective Bidder(s) on Bid # 36343 - Rental of Standard and Trailerable Portable Toilets for New Jersey Marine Terminals (NJMT)

I. CHANGES/MODIFICATIONS TO BID DOCUMENTS

The following changes/modifications are hereby made to the bid documents.

1. In the Specifications, Page 2 of 6, Section II.A. "Standard Portable Toilets":
 - delete the first paragraph in its entirety and replace it with: "The Contractor shall furnish and deliver Standard Portable Toilets, refurbished to like-new condition, in the quantities listed in Section III, Item Nos. 1 through 3 and 6 through 10, below. Toilets provided by the Contractor are subject to approval by the Port Authority".
 - In the second paragraph, first sentence, second line, delete the word "NEW". Also in this sentence, after the phrase "Standard Portable Toilets", insert the words "refurbished to like-new condition". After the final sentence of this paragraph, add the sentence "Toilets provided by the Contractor are subject to approval by the Port Authority".
2. In the Specifications, Page 2 of 6, Section II.B. "Trailable Toilets" in the first paragraph, delete the first sentence in its entirety and replace it with: "The Contractor shall furnish and deliver Trailerable Toilets, Comfort Coach or approved equal, refurbished to like-new condition, in the quantities listed in Section III, Item Nos. 4 and 5, below. Toilets provided by the Contractor are subject to approval by the Port Authority".
3. In the Specifications, Page 2 of 6, Section II.B. "Trailable Toilets", in the first bullet, delete "20-foot length" and replace it with "minimum 20-foot length and maximum 24-foot length."
4. In the Specifications, Page 3 of 6, Section IV., "Service", in first paragraph, last sentence, after the words "sanitizing entire interior," insert the words "performing necessary repairs,".

II. BIDDERS' QUESTIONS AND ANSWERS

The following information is available in response to questions submitted by prospective Bidders. The responses should not be deemed to answer all questions that have been submitted by Bidders to the Port Authority. It addresses only those questions that the Port Authority has
