In Part IV, "Signature Sheet, Name And Residence Of Principals Sheet And Pricing Sheet(s)", delete "260" and replace it with "104" in the row titled "Item A-1, One 15-Cubic Yard Compactor (Mixed Paper, Bottles, Cans, Plastic)" and the column titled "Estimated No. Annual Pickups" of "Section A: Recyclables - Pricing Sheet – Year One (1)" and "Section A: Recyclables - Pricing Sheet – Year Two (2)."
- ii. In Part IV, "Signature Sheet, Name And Residence Of Principals Sheet And Pricing Sheet(s)", delete "104" and replace it with "15" in "Section B – Pricing Sheet – Year One (1)" and "Section B – Pricing Sheet – Year Two (2)" in the row titled "Item B-4, "One 4-Cubic Yard Container (Animal Carcasses)" and the column titled " Estimated No. of Annual Pickups"
- iii. In Part V, "Specifications", "Section 5, "Item Specific/Locations", Item A-1, "15-Cubic Yard Compactor - Terminal B (Loading Dock)" paragraph a. in the first sentence, after the word "performed" add the words "as required herein".
- iv. In Part V, "Specifications", "Section 5, "Item Specific/Locations", Item E-1, "30-Cubic Yard Compactor - North Yard" paragraph a. in the first sentence, after the word "performed" add the words "as required herein".
