The following questions were received from RFP recipient(s). The questions and the corresponding Authority answers are provided for your information and use, as appropriate.

- **Question #1**: Does the minimum 30 staff team requirement refer to just employees of the prime firm or can the 30 employees be a team of prime and subconsultant staff?
- Answer #1: The Proposer Requirement in item B. applies to the prime firm. See amendment 1., above.
- <u>Question #2</u>: Please clarify how to best complete the estimated dollar value of the work and percentage of the total contract value when completing the MBE/WBE Participation Plan and Affirmation Statement (PA 3760C).
- Answer #2: The Consultant shall include their MBE/WBE Participation Plan and Affirmation Statement (PA 3760C) with their task order proposals. Please see amendment 2., above.
