C. In Part V, section 1.1.2, add the following as the second and last sentence,

“Brand name or equal descriptions are used as a means to define the performance or other salient characteristics of procurements. In the subject Bid, even if the phrase “or approved equal” is inadvertently omitted, it is implied after any brand name.”

D. In Part II, section 6, Duration of Contract, in the second paragraph change “four hundred and twenty (420) to “five hundred and forty (540)”.

E. In Part III, section 5, Delivery Schedule, in the second paragraph change **“four hundred and twenty (420)”** to **“five hundred and forty (540)”**.

F. In Part III, section 6, Progress Schedule, item 2, in the first line change **“three hundred and ninety (390)”** to **“five hundred and ten (510)”**.

G. In Part III, section 6, Progress Schedule, item 3, in the first line change “**four hundred (400)**” to “**five hundred and twenty (520)**”.

This communication should be initialed by you and annexed to your Bid upon submission.

In case any Bidder fails to conform to these instructions, its Bid will nevertheless be construed as though this communication had been so physically annexed and initialed.
