Contract BP-694.504A – Brooklyn Cruise Terminal – Pier 12 Shore Power and Service Substations. Estimate Range: \$5M – \$10M. **Bids Due: Tuesday, December 11, 2012.**

The work under this contract consists generally of constructing a shore-based power system for use by docked cruise ships, which system shall include outdoor substation and connections to Con Edison grid, indoor substation and vault, jib crane, associated power ductbanks, building and site modifications including related electrical, HVAC, plumbing, fire protection, structural, geotechnical, and environmental work at Pier 12 and the vicinity thereof at Brooklyn Cruise Terminal, Brooklyn, New York.
