The work under this contract consists generally of replacement of concrete median barriers; rehabilitation of concrete-encasement of the steel columns associated with the George Washington Bridge Bus Station and the Air Rights Buildings; electrical work associated with barrier replacement and concrete repairs; traffic safety enhancements; replacement of existing Water System 'C' main and lateral lines of the Trans-Manhattan Expressway; and related work at the Upper Level of the main span of the George Washington Bridge, the Upper and Lower Level Expressway Lanes of the Trans-Manhattan Expressway, and vicinities thereof at the George Washington Bridge in the states of New York and New Jersey. - 1.) The bidder must be able to demonstrate the following:
  - a. That the bidder has a minimum of ten (10) years construction experience and has completed (or substantially completed) as a prime or general contractor at least three (3) contracts of size, type and complexity comparable to the work of this Contract.
  - b. That the bidder has a minimum of ten (10) years of experience coordinating and managing work in an urban, highly congested area, subject to high traffic volume requiring extensive maintenance of traffic.

- c. That the bidder's full-time Project Manager and full-time Superintendent shall each have a minimum of ten (10) years construction experience on contracts comparable in type, size and complexity to the work of this Contract and each shall have participated in at least one project comparable in size, type and complexity to the work of this Contract.

A Bid submitted by a bidder who does not meet the prerequisite Qualification Information requirements will be considered non-responsive and the bidder's Bid will not be eligible for acceptance by the Authority.
