Contract documents may be seen at the Contract Desk on the 3rd Floor, 3 Gateway Center, Newark, NJ and may be obtained upon receipt of a non-refundable payment of \$100.00 per set. If contract documents are not immediately available, prospective bidders are encouraged to pre-order the contract documents by sending the payment of \$100.00 per set in advance. The contract documents will be shipped by overnight delivery at no additional cost as soon as they become available. Only company checks or money orders payable to the order of The Port Authority of New York and New Jersey will be accepted. Bids Due: **Tuesday, December 16, 2014.** The work under this contract consists generally of miscellaneous facility improvements, including repair, rehabilitation, demolition and construction of interior and exterior building systems including curtain wall, roof, concrete slab, ceiling, floor tile, interior finishes, painting, mechanical, HVAC, electrical, electronics, sprinkler, plumbing, conveying systems, interior landscaping and utility runs within buildings, site work including rehabilitation, demolition and construction of concrete and asphalt paving, landscaping, concrete pads, sidewalks, curbs, erosion control, cracks and slurry seals, irrigation, pavement markings, concrete traffic barriers, signage, traffic signals, electrical and communications ductbanks and wiring, drainage structures and piping, guide rails, exterior screening, exterior demising walls, fencing, and utility runs to building lines and maintenance and protection of pedestrian and vehicular traffic and related work, at various locations at Port Newark, Elizabeth-Port Authority Marine Terminal and Port Jersey Marine Terminal, and the vicinities thereof, New Jersey, all as directed by Engineer and in accordance with Work Order(s) issued by the Engineer. **For questions, call Marjorie Crump at (201) 395-3453 or email – mcrump@panynj.gov.**
