Use the left lane to take the exit toward Belt Parkway E/Kennedy Airport. Merge onto Belt Pkwy. Take exit 19 for NY-878/Lefferts Boulevard toward Nassau Expy/Interstate 678/Van Wyck Expy/Kennedy Airport/Long Term Parking. Keep left at the fork, follow signs for New York 878/Nassau Expressway/Van Wyck Expressway/Airport and merge onto NY-878 E/Nassau Expy. Continue on NY-878 E/Nassau Expy.
