Directions to Impound Facility from Verrazano-Narrows Bridge: Take I-278 E to Ditmars Blvd in Queens. Take exit 6 from Grand Central Pkwy. Head northeast on Verrazano-Narrows Bridge. Keep right to stay on Verrazano-Narrows Bridge. Merge onto I-278 E. Keep right at the fork to stay on I-278 E. follow signs for Bklyn Qns Expressway/Triboro Bridge. Keep left to stay on I-278 E. Keep right at the fork to continue on Brooklyn Queens Expy E. Use the right lane to take the Grand Central Pkwy E exit toward Terminal B/Terminal C/Terminal D. Use the right lane to merge onto Grand Central Pkwy. Take exit 6 for 94 St toward Parking B. Take Runway Drive to Bowery Bay Blvd. Merge onto Ditmars Blvd. Turn left onto 94th St. Keep left to continue on LaGuardia Rd. Sharp left onto Central Terminal Dr. Continue straight onto Runway Drive. Continue onto Bowery Bay Blvd. Go straight until the road ends.
