NOTICE OF INTENT TO SOLE SOURCE

The Port Authority of New York and New Jersey intends to establish a sole source contract with **Indeck Power Equipment Company (Indeck), located in Wheeling, IL**, to provide the following:

TITLE: Check and Recalibrate Services of the Indeck Generators located at the Central Heating and Refrigeration Plant (CHRP) at Newark Liberty International Airport (EWR)

BRIEF DESCRIPTION: The Port Authority intent is to enter into a sole source agreement with Indeck to check and recalibrate all analog input and output signals for the generators, field transmitters, field actuators, and control valves and provide testing, startup and shut down services of Burner Management System (BMS), generators, SCADA (Supervisory Control and Data Acquisition) System and High Temperature Hot Water generators (HTHW) on an annual basis at the Central Heating and Refrigeration Plant (CHRP) located in Newark Liberty International Airport (EWR) with Indeck licensed and certified technicians.
