Port Authority of New York & New Jersey Stationary/Watch Engineer Candidate Information Bulletin

Thank you for your interest in the Port Authority of New York & New Jersey. As one of the premier public agencies in the nation, the Port Authority offers exciting career opportunities and competitive benefits to those job seekers who qualify to join our staff. The information below provides information about the Stationary/Watch Engineer job as well as information about the selection process.

JOB INFORMATION

WHAT ARE THE MAJOR RESPONSIBILITIES OF THE JOB?

The Stationary/Watch Engineer job title requires a 40-hour work week and is required to work rotating shifts, nights, weekends and holidays, overtime on short notice, and during inclement weather. You must be able to obtain and maintain a Class B or above Commercial Driver's License (CDL) with medical card and endorsements.

The Stationary/Watch Engineer is a lead-capacity job title that requires incumbents to perform a variety of journey-level duties in the installation, operation, maintenance, repair and alteration of utility systems and related auxiliary equipment. Such equipment includes, but is not limited to, air conditioning and ventilation systems, pneumatic and electrical controls, high-and low-pressure boilers, high temperature hot water generators, large capacity chiller units, and fire protection systems. Incumbents will also troubleshoot and diagnose problems on a variety of plant/facility systems and are responsible for the security and satisfactory operation of a plant/facility on all off tours. Shift work may be required.

WHAT ARE THE MINIMUM REQUIREMENTS?

Candidates must meet all of the qualifications below:

- Possess a current valid High Pressure Boiler Operator's License issued by the City of New York
 OR a New Jersey Blue Seal Boiler Operator's License
- Possess a current valid New York City Refrigeration Machine Operator's License <u>OR</u> a Blue Seal Refrigeration Machine Operator's License (Class II) issued by the State of New Jersey
- Possess a current valid New York Fire Department Certificate of Fitness for Standpipe or Sprinkler Operation <u>OR</u> a Black Seal Fireman's License issued by the State of New Jersey
- Possess a current valid U.S. Environmental Protection Agency (EPA) Refrigerant Technician's Certificate (RTC)
- Possess a Certificate in Pesticide Application in New York or New Jersey (selected applicants
 without a Pesticide application certificate in New York or New Jersey must obtain this certificate
 within six months of employment)
- High School Diploma or GED

- Valid Driver's License
- Must be able to obtain and maintain a Commercial Driver's License (CDL) with endorsements
- At least three years of full-time paid work experience as a journey-level Stationary/Watch Engineer.
- Qualify on the Stationary/Watch Engineer Written Test and Practical Test
- Qualify on a thorough background check
- Qualify on a pre-hire medical evaluation

Failure to meet <u>any</u> of the requirements above will disqualify candidates from consideration.

WHERE WOULD I BE WORKING?

Depending on the location where vacancies exist, qualified candidates may be assigned to work at any of the Port Authority facilities below:

HOW MUCH DOES THE JOB PAY?

\$45.33 per Hour (subject to collective bargaining agreement)

DOES THE POSITION OFFER BENEFITS?

Yes. In addition to full health benefits, the position provides all tools, equipment and uniforms needed for the job.

WHAT CAREER OPPORTUNITIES EXIST FROM THIS POSITION?

Port Authority employees are eligible to participate in internal promotional evaluations for positions in which they meet the requirements. Opportunities exist in the Structural, Mechanical, Electrical, Utility Systems, Buildings & Grounds, Automotive and General Maintenance fields as well as for maintenance supervisory positions.

SELECTION PROCESS

HOW DOES THE SELECTION PROCESS WORK?

The selection process for the Stationary/Watch Engineer job title consists of the following components:

- 1. Written Examination
- 2. Practical Examination
- 3. Background Check and Medical Exam

Each component is described in further detail below:

Written Examination *

Exam Delivery Format: Computer-Based

Number of Questions: 150

Question Format: Multiple-Choice

Time Limit: 3 Hours

Exam Content: The Stationary/Watch Engineer Written Examination is designed to

assess candidates' knowledge/ability in the following areas:

Heating and Heating Systems

• A/C and Refrigeration Systems

Auxiliary Equipment

Pumps and Controls

Fire Protection, Fire Safety and Sprinkler Systems

HVAC Electrical Systems

Stationary Engineering Systems – Operation, Maintenance and Repair

* Number and nature of Written Examination questions is subject to change

Exam Results: Candidates will receive test results at the test site immediately after completing the

examination.

Fee: \$25 non-refundable/non-transferable fee payable by MasterCard or Visa personal

or pre-paid credit card is required

The \$25 testing fee will be waived for qualified U.S. military veterans who provide proof of military service. To request a military waiver of the testing fee, email Waiver Request@panynj.gov and attach an electronic copy of your DD214 or military orders. Include in the text of your email your Full Name, Contact Phone Number, Job title of the test you were invited for, and Eligibility ID as listed in your testing notice email. The Subject line of your email should be "Veteran Testing Fee Waiver Request."

The \$25 testing fee will also be waived for qualified candidates receiving one or more forms of public assistance listed below who provide the required documentation.

- General Assistance Please provide a copy of your ID card and documentation on letterhead from the social service agency in your state, dated within the past month.
- Public Assistance in the form of Temporary Assistance for Needy Families
 (TANF)/Family Assistance or Safety Net Assistance Please provide a copy of

- your ID card and documentation on letterhead from the social service agency in your state, dated within the past month.
- Eligible for Medicaid, or receiving Supplemental Security Income (SSI) Please provide a copy of your latest annual awards letter and a copy of your ID card that shows your Medicaid number.
- Certified Job Training Partnership Act/Workforce Investment Act/WorkFirst
 NJ Act eligible through a state or local social service agency Please provide a copy of your ID card and documentation on letterhead from the social service agency in your state, dated within the past month.

To request a waiver of the testing fee, email Waiver Request@panynj.gov and attach an electronic copy of the required documentation. Include in the text of your email your Full Name, Contact Phone Number, Job title of the test you were invited for, and Eligibility ID as listed in your testing notice email. The Subject line of your email should be "Testing Fee Waiver Request."

Test Location:

Performance Assessment Network (PAN) Test Centers throughout New York and New Jersey. You can choose your test time and location when you schedule for testing through PAN.

Required Identification: One form of official, government issued photo identification.

The examination is of a multiple-choice format and is administered on a computer. Candidates may complete a tutorial that describes the procedures for the computer-based administration prior to beginning the exam. The time limit for the exam is 2 hours. Candidates should be prepared to be at the test site for up to 3 hours, factoring in check-in, test administration, and check-out.

Only candidates who qualify on the Written Examination will be eligible to proceed to the next step in the Selection Process, the Practical Examination. You will receive your results at the test site immediately after completing the test.

Practical Examination

Candidates are typically scheduled for the Stationary/Watch Engineer Practical Examination within three months of qualifying on their Written Examination, depending on the hiring needs of the Agency.

Exam Delivery Format: Hands-on demonstration of skill/ability

Number of Test

Problems: 5

Time Limit: Each Test Problem has a time limit. Candidates should prepare to be at the test site

for approximately 4 hours

Test Problems: Hands-on demonstration of the following skills/abilities: *

• **Troubleshooting a Rooftop Package Unit:** Diagnose, troubleshoot and repair of a non-functioning commercial heating/cooling unit.

- HVAC Circuits/Power Sources: Identify HVAC components and their operations and logically wire and start the equipment according to instructions provided.
- Steel Pipe & Copper Pipe Loop: Construct a 2" steel to copper pipe loop following
 the specifications from a shop diagram and involves cutting, threading, soldering,
 brazing and correctly installing valves, fittings, etc.
- Activation of a Package Air Conditioning Unit: Demonstrate knowledge of how to recover refrigerant from a leaking line set and re-commission the unit back into service. You must completely describe all components of the unit, how they operate and how they are serviced.
- Central Heating and Refrigeration Plant (CHRP) Operation Interview. This portion
 of the Watch Engineer performance test is designed to measure your knowledge
 and ability to operate and maintain a Central Heating and Refrigeration Plant,
 including its component equipment that includes 4 50 million BTU Hot Water
 Generators and 4 2000 ton Chiller Units. (Candidates invited to the practical test
 are typically given an opportunity to walk through the CHRP prior to their scheduled
 practical test date.)

Exam Results: Results for the Practical Examination are typically emailed to candidates within

approximately one month of the Practical Examination date.

Required Identification: One form of official, government-issued photo identification and Written Test

Bring to the Test

Location: Candidates should wear normal work clothes, including work boots or safety shoes.

Candidates <u>should not</u> bring any tools, books, equipment, etc. to the test. Personal protection equipment such as gloves or prescription safety glasses are allowed, but

everything is also supplied at the test site.

Practical Examination

Raters: Candidates' performance on Stationary/Watch Engineer Practical

Examination test problems is rated by trained, experienced proctors with a

background in the maintenance field. Only candidates who qualify on the Practical Examination are eligible to proceed to the next step in the Selection Process, the

Background Check and Medical Exam.

Background Check and Medical Exam

The Background and Medical Check typically come at the time of a conditional job offer and are conducted concurrently. For the Background Check, the information a candidate submitted on his/her employment application is verified by a background check company, including education, employment history, driver's license, and criminal history. For the Medical Check, candidates are evaluated by the Port Authority's Office of Medical Services physicians to ensure that they can meet the qualifications of the job (with or without accommodation). We strongly encourage candidates to review the requirements for obtaining and maintaining a Commercial Driver's License.

Candidates who qualify on the written examination, practical examination, background check, and medical check are considered eligible to be considered for placement in the Stationary/Watch Engineer job title based on the hiring needs of the Agency. **However, qualification on the selection process <u>does not</u> guarantee placement into a vacant position.**

Question and Answer

ARE THERE ANY STUDY MATERIALS FOR THE EVALUATION PROCESS?

No. We expect candidates to demonstrate their knowledge/experience through the evaluation process.

HOW LONG DOES THE SELECTION PROCESS TAKE?

The timing is highly influenced by the hiring needs of the Agency for this position as well as the speed at which candidates' background check information can be obtained/verified.

IF I QUALIFY ON THE EVALUATION PROCESS, HOW LONG DOES MY QUALIFICATION LAST?

Your qualification will remain for 1 year from the date you qualified on the Practical Test. This timeframe may be extended at the discretion of the Port Authority.

IF I QUALIFY ON THE EVALUATION PROCESS, IS IT ASSURED THAT I WILL GET HIRED?

No. Candidates who qualify on the written examination, practical examination, background check, and medical check are considered eligible to be considered for placement in the Stationary/Watch Engineer job title based on the hiring needs of the Agency. *However, qualification on the selection process does not guarantee placement into a vacant position.*
