



The Port Authority of New York and New Jersey (The Authority) hereby amends the subject award letter as follows:


Second Paragraph **delete**: “The Authority elects to require you to furnish a performance and payment bond in accordance with the terms of the Contract. A copy of the required bond form is enclosed, which should be executed by you and your surety and returned to Sharon Allen of the Port Authority of New York and New Jersey, 2 Montgomery Street, 3<sup>rd</sup> Floor, Jersey City, NJ 07302 along with a copy of the invoice from the bonding company and bond broker if applicable, for the premium for said bond.”

Insert as the new second paragraph: “The Authority elects not to require you to furnish a performance and payment bond.”

Third Paragraph **delete**: “Please note that under the Contract clause entitled “Performance and Payment Bond”, you are required to return the executed bond within seven days.”

All other terms and conditions as outlined in the March 5, 2014 award letter remain the same.
