- Report all security incidents or suspicious activity immediately to Joseph Farley (FSO) and Port Authority Police at (973) 578-2180.
- Maher Terminals is a Restricted Area
- Maher Terminals is at MARSEC Level One
  - Normal Operating Conditions
  - The minimum operating condition for the port and Marine facilities at all times.
- ▶ The FSO would notify Escorts of additional Security requirements if the MARSEC Level is increased
- ▶ 24 hr prior day notice required for all visitors
- ▶ All personnel requesting unescorted access to terminal MUST have a TWIC Card
- ▶ Non TWIC Card holders will require an Escort by a valid TWIC Card Holder
- ▶ All Escorts must complete Security Training to meet USCG 33CFR 105.215 requirements
- ▶ Escorts must have a valid TWIC Card that must be in their possession at all times while on the facility
- ▶ Escort must provide non TWIC Card holders continuous side by side escort at all times
- ▶ Escort ratio is 1 TWIC Card holder to 5 non TWIC Card holders
- ▶ Escorts will be responsible for the actions of non TWIC Card holders they are escorting and will assume liability and /or fines for their actions
- ▶ Once escort training is completed Escorts will be issued a terminal escort card
- ▶ The Escort Card along with their TWIC card must be presented to the gate security officer each time they request terminal access
- ▶ If at any time you lose contact with the person(s) you are escorting or the non TWIC card holder is acting suspicious you must immediately contact the Maher Terminals FSO and Port Authority Police
- ▶ Failure to follow this policy will result in your escort privileges being revoked

While visiting PNCT please note the following rules & procedures:

1. PNCT is a Restricted Area. TWIC is required for entrance onto the Terminal.
2. 24 hr notice prior day notice is required for all visitors.
3. Non-TWIC cardholders will require an Escort by a valid TWIC holder.
4. Await Security Escort.
5. Escorts must have a valid TWIC and completed Security Training in accordance to 33 CFR 105.215 as well as PNCT security training.
6. Escort ratio is one TWIC cardholder to five non-TWIC holders.
7. A PNCT Escort Card will be issued to approved escorts.
8. If you lose contact with the person(s) you are escorting or they are acting in a suspicious manner contact Security and the FSO immediately:
  - a. 24 Hr Security (973) 465 9580
  - b. FSO: Frank Chimento (973) 522 2235
9. In the event of an emergency, call the PA Police at (973) 578 2180
10. Wear High Visibility Vests when out of vehicle.
11. A hard hat is to be worn anytime on the string piece.
12. The Terminal Speed limit is 15mph.
13. Do not drive or enter the Straddle field. Security will escort you to your destination. This is for your safety and those around you.
14. In case of an Emergency, you will be notified by a verbal broadcast.
15. Stop at all intersections.
16. Turn your headlights on during inclement weather.
17. Never leave your vehicle idling and use parking breaking.
18. Report any incident/accident to PNCT management immediately.
19. Call the 24-hour Security number at 973 465 9580 for:
  - a) Escort back to the main gate
  - b) If you see anything suspicious

  - The minimum operating condition for the port and Marine facilities at all times.
- The FSO or Terminal Security would notify Escorts of additional Security requirements if the MARSEC Level is increased
- 24 hr prior day notice required for all visitors
- All personnel requesting unescorted access to terminal MUST have a TWIC Card
- Non TWIC Card holders will require an Escort by a valid TWIC Card Holder
- All Escorts must complete Security Training to meet USCG 33CFR 105.215 requirements AND have documentation of such training
- Escorts must have a valid TWIC Card that must be in their possession at all times while on the facility
- Escort must provide non TWIC Card holders continuous side by side escort at all times
- Escort ratio is 1 TWIC Card holder to 5 non TWIC Card holders
- Escorts will be responsible for the actions of non TWIC Card holders they are escorting and will assume liability and /or fines for their actions
- Once escort training is completed Escorts will be issued a terminal escort card
- The Escort Card along with their TWIC card must be presented to the gate security officer each time they request terminal access
- If at any time you lose contact with the person(s) you are escorting or the non TWIC card holder is acting suspicious you must immediately contact the APM Terminals Security, the FSO and Port Authority Police
- Failure to follow this policy will result in your escort privileges being revoked

- Non TWIC Card holders must be escorted by an Authorized TWIC Escort
- All Escorts must complete Security Training to meet USCG 33CFR 105.215 requirement
- Escorts must have a valid TWIC Card that must be in their possession at all times while on the facility

- An NYCT Escort Card will be issued to all approved Escorts
- The Escort Card along with their TWIC card must be presented to the gate security officer each time they request terminal access
- If at any time you lose contact with the person(s) you are escorting or the non TWIC card holder is acting suspicious you must immediately contact the NYCT FSO and Port Authority Police
- Failure to follow this policy will result in your escort privileges being revoked
