ALL VEHICLES TO BE SOLD BY LOT NUMBER AND ARE SOLD AS ABANDONED, FREE AND CLEAR OF ANY LIENS, ENCUMBERANCES OR SUMMONSES. SOME VEHICLE TITLES WILL BE RESALEABLE TITLES N.J. DMV FORM OS-SS-88. OTHER TITLES WILL BE JUNK TITLES.
