DESCRIPTION: Provide a fully functional Airport Parking Access and
Revenue Control System (PARCS) for John F. Kennedy
International Airport (JFK), LaGuardia Airport (LGA),
Newark Liberty International Airport (EWR), and
Stewart International Airport (SWF)

The Contractor's responsibilities shall include, but not be limited to, the following:

- i) design and implement and provide preventative and remedial system maintenance
- ii) provide services and materials for the maintenance, operation, and replacement of all existing PARCS hardware, software and the local area network communications equipment.
- iii) maintain and ensure operational functionality of the Existing PARCS at each airport and decommission and remove the Existing PARCS at each airport
- iv) provide training as required to implement the system.
