Don't hesitate to report suspicious activity. This program awards eligible individuals to receive cash awards from \$50 to \$1,000 for reporting suspicious activity, preventing airport crimes or breaches of airport security. For more information and eligibility requirements visit their website at:

## Security Is Everyone's Responsibility Take Action Speak Up

Remain situationally aware at all times. Take action to address individuals who seem lost, aren't dressed for the environment, don't have a badge, or who blatantly attempt to evade access control measures. This collective effort will enhance the security of LaGuardia Airport.

Piggybacking occurs when an unauthorized person slips in through a door before it closes or when an authorized person allows someone to follow them through a door to secure area(s). Both practices are gaps in security with the potential to expose the airport to a variety of threats. If you do not carry a valid SIDA badge, do not enter a secured area or go through a secured door by following a valid SIDA badge holder. If you carry a SIDA badge, make sure you are following the correct procedures when accessing a secured area.



# **Review of Airport Security ID Cardholder Responsibilities**

It is the responsibility of every individual issued an Airport ID card:

- 1. While in SIDA areas of the airport, individuals who are not under escort must DISPLAY the Airport Security ID card in full view, above waist level, on their outermost garment. Airport ID card must be presented upon demand in response to a challenge.
- 2. REMEMBER TO CHALLENGE the authority or purpose of a person without proper escort who attempts to enter the SIDA/Secure areas of the airport and to prevent him or her from entering the SIDA/Secure areas; and to challenge someone who is in the SIDA/Secure areas if not displaying a valid Airport ID and escort him/her from the SIDA/Secure areas, if that individual does not offer valid Airport ID, report the incident to the Port Authority Police as soon as possible while attempting to keep the individual within view.
- 3. Do not wear airport ID badge off airport property.
- 4. Airport ID badge should never be duplicated, altered or shared on any social media platforms such as Facebook, Twitter, Snapchat, Instagram, WhatsApp, LinkedIn, etc.
- 5. Do not use airport ID badge to bypass TSA Screening Checkpoint when boarding an aircraft.
