

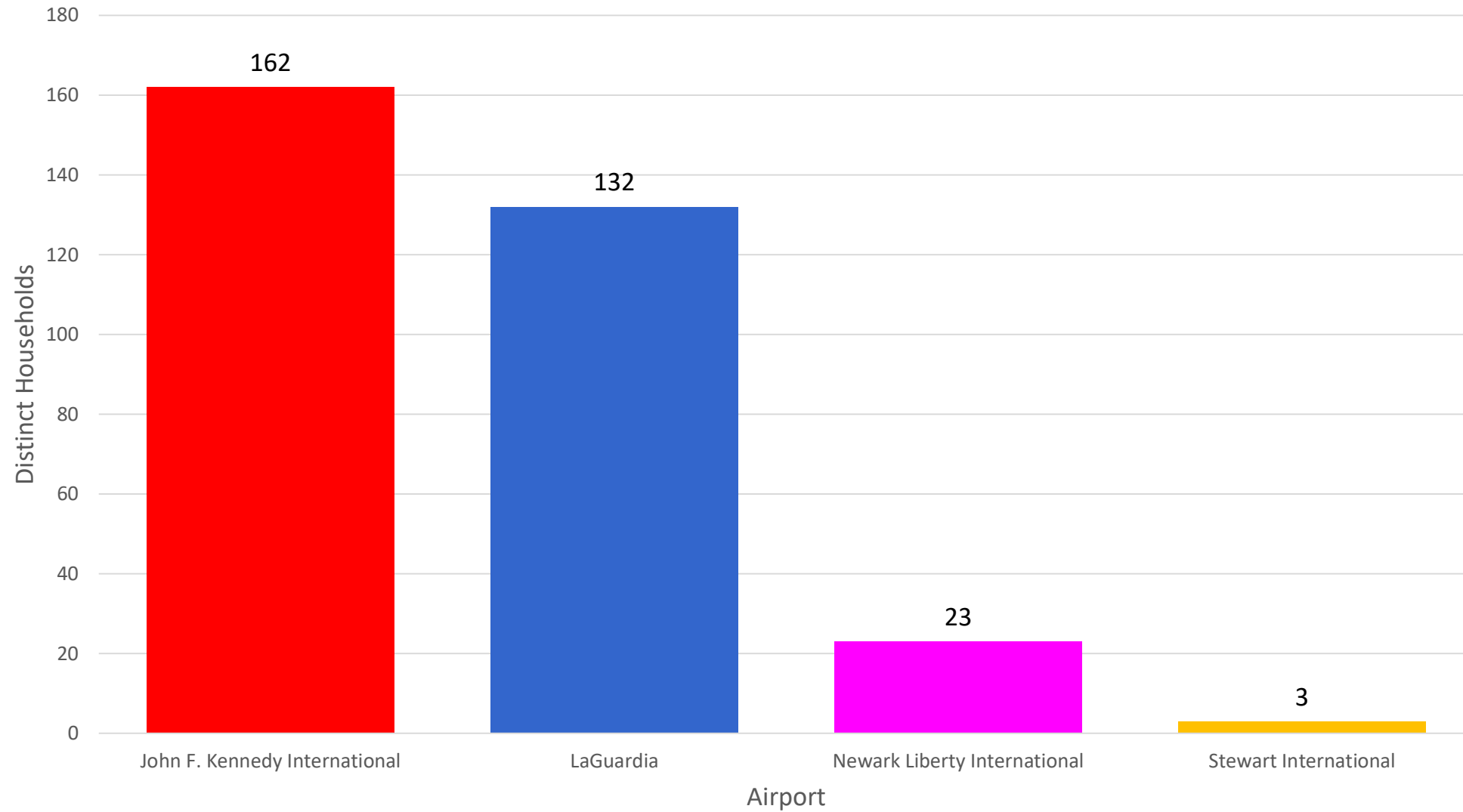

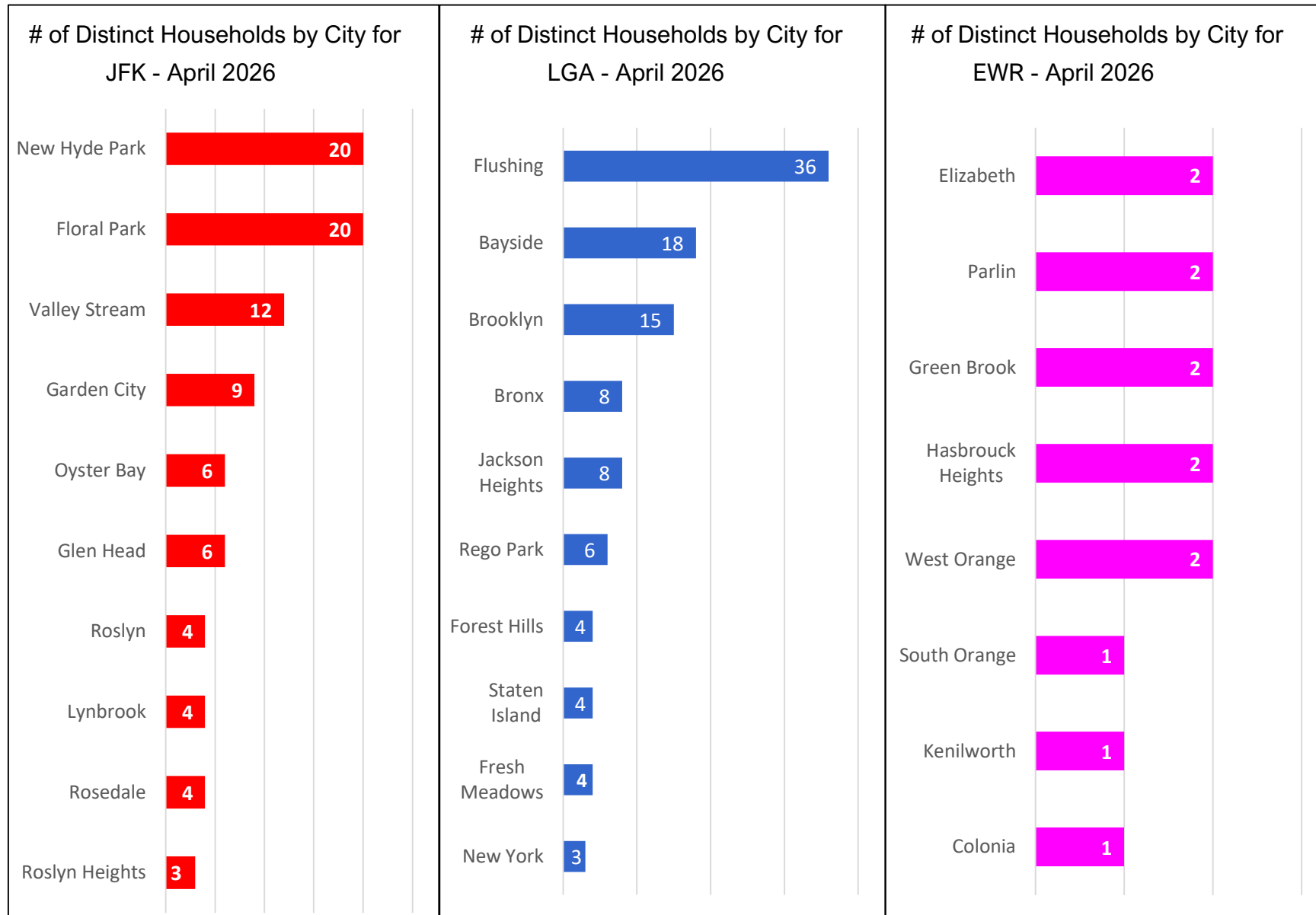

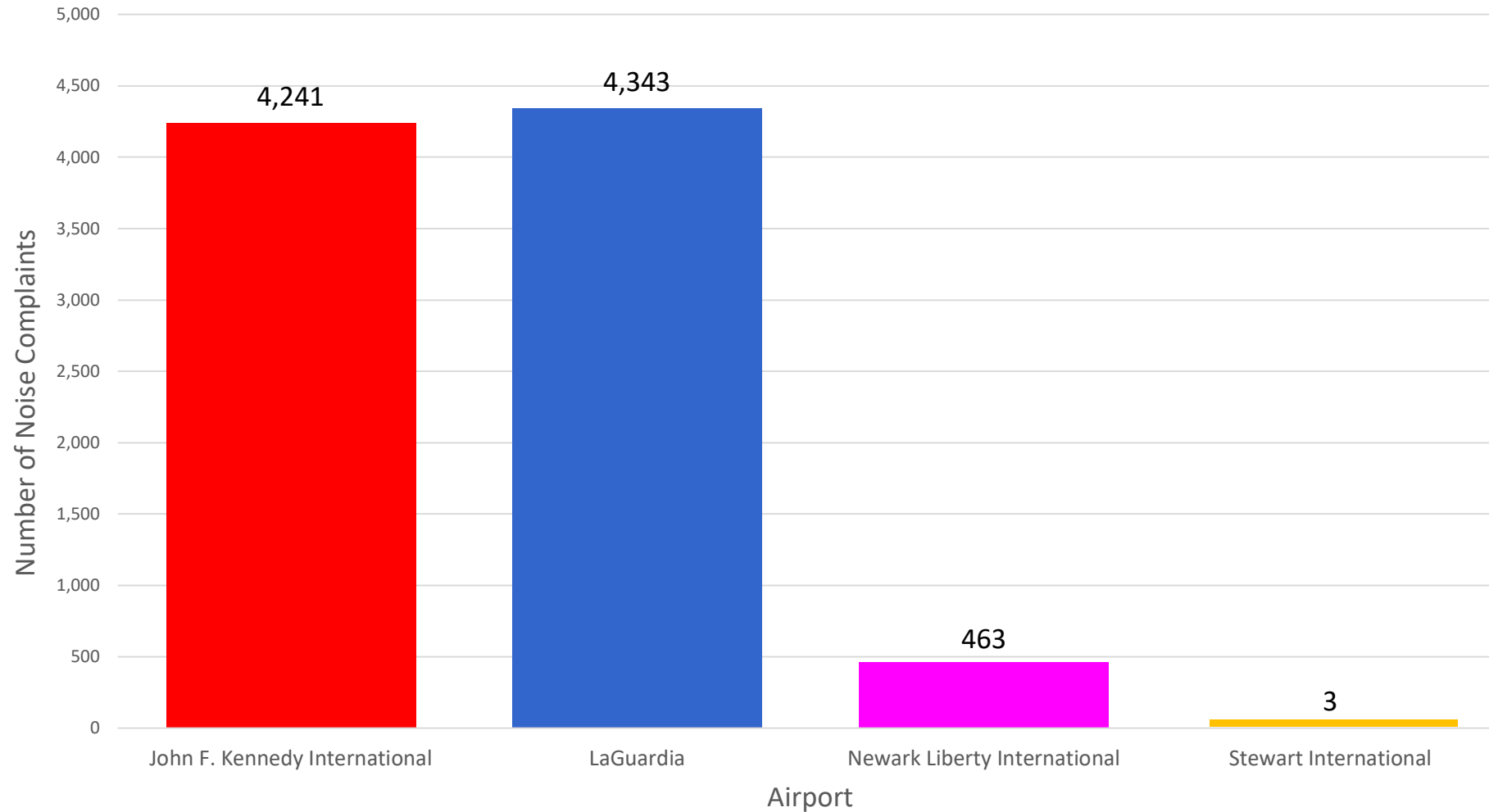
Households Statistics, by Location* - April 2026

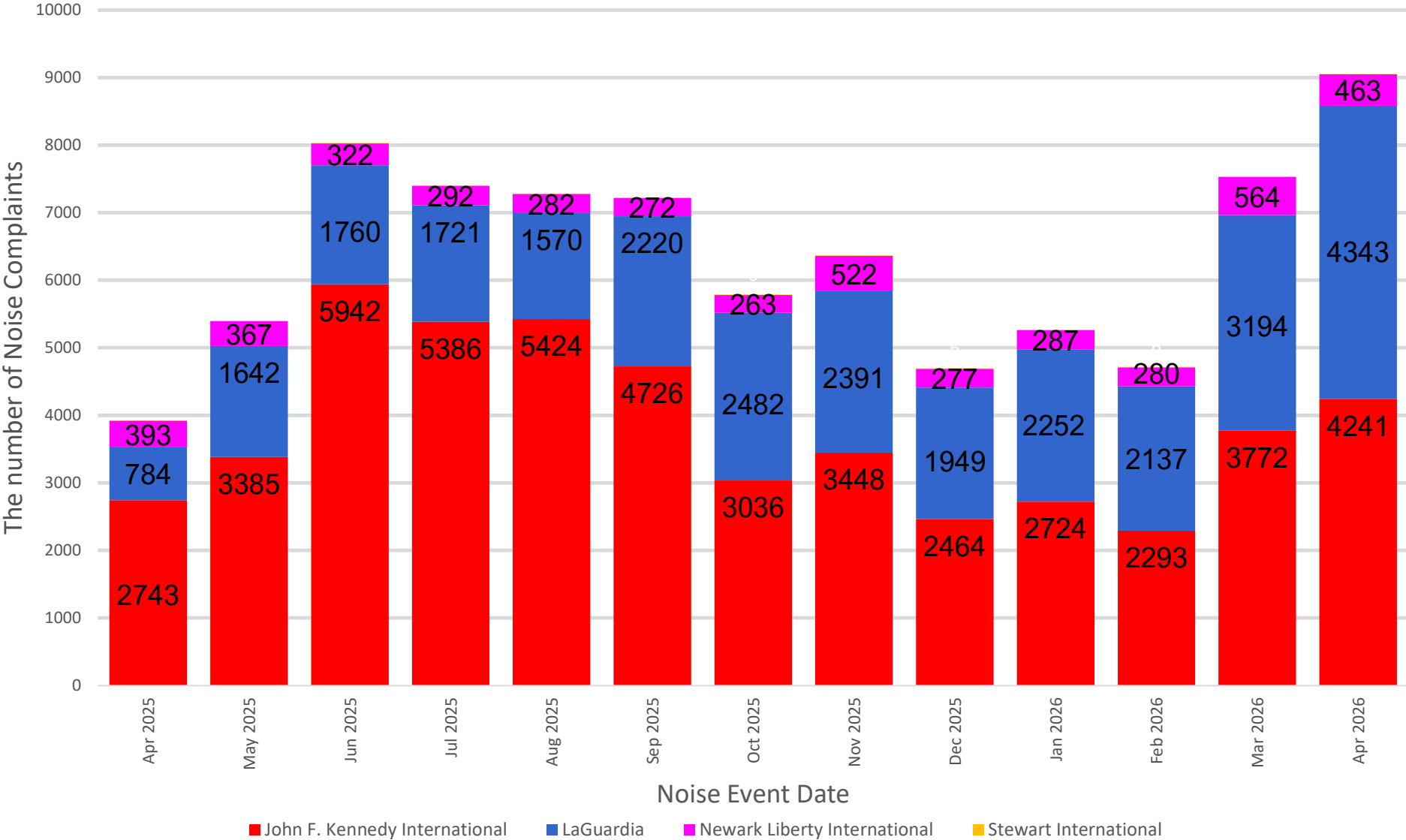

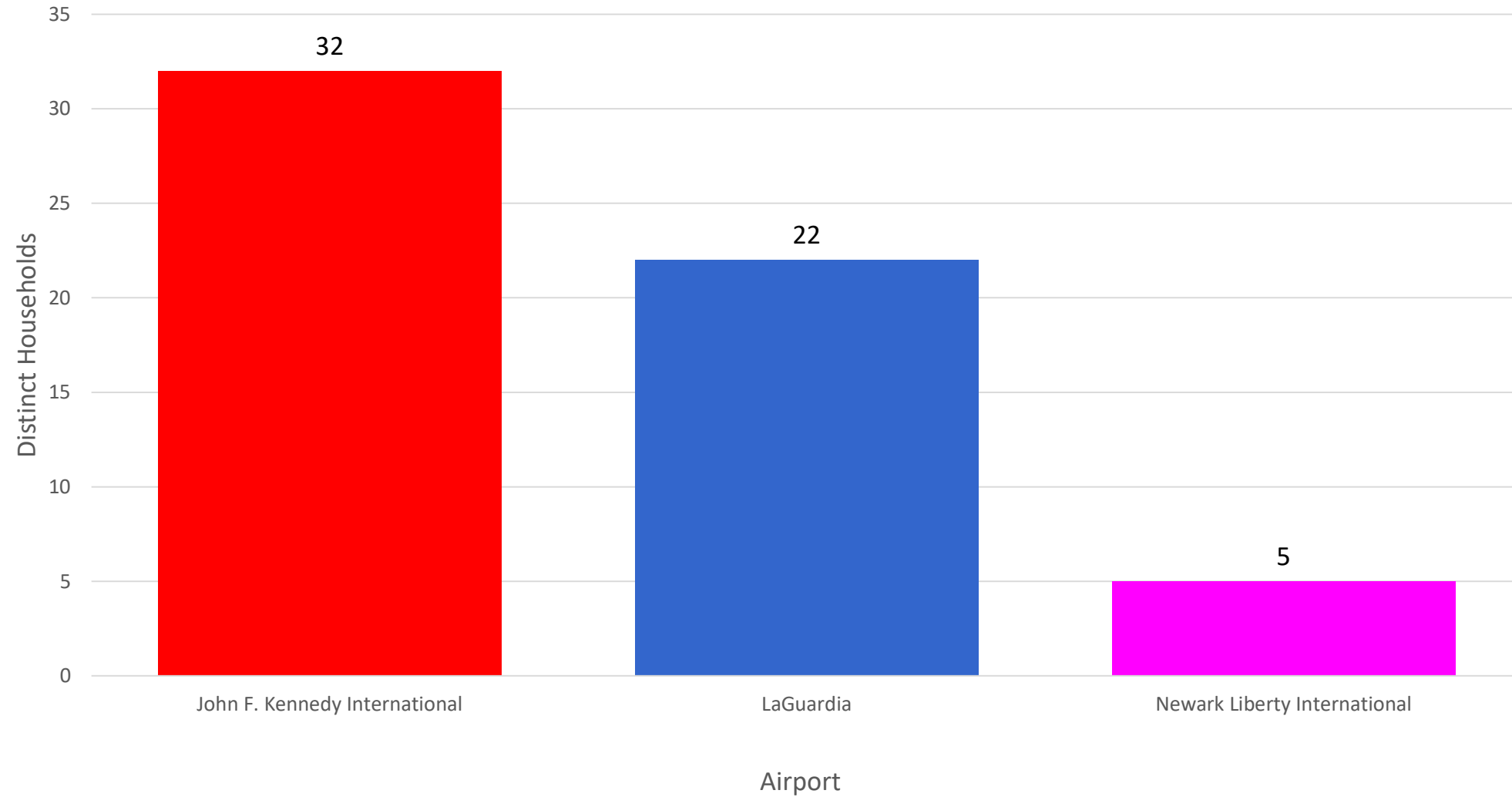

Notes:

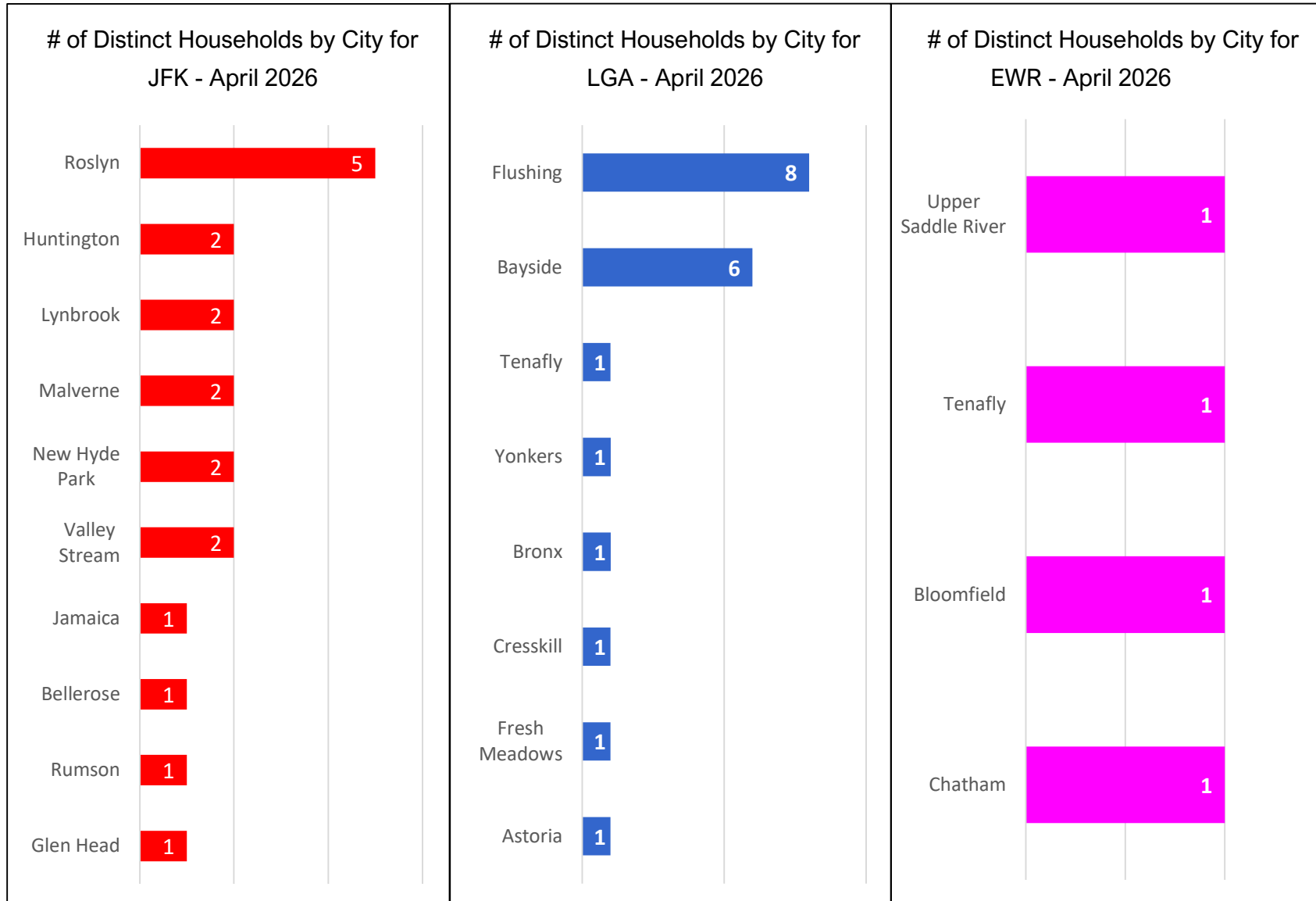

2. Complaints from Third-party app(s) are kept and stored in the same database as complaints received through Port Authority PlaneNoise system.
3. While in the same database, data is compiled and reported a) for each individual noise source, and, b) as a combination of all complaint sources.

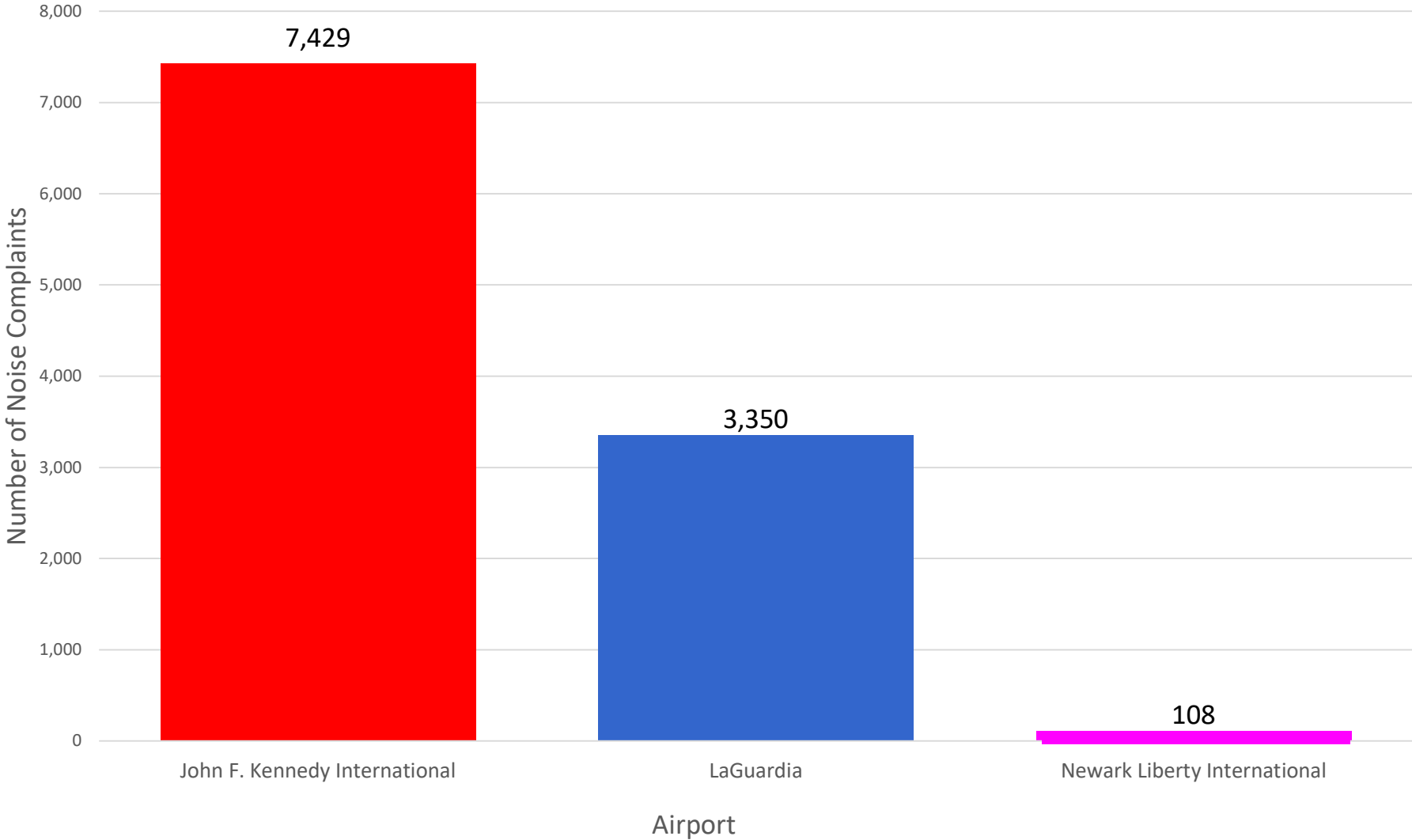
Third-Party App Households Locations* - April 2026

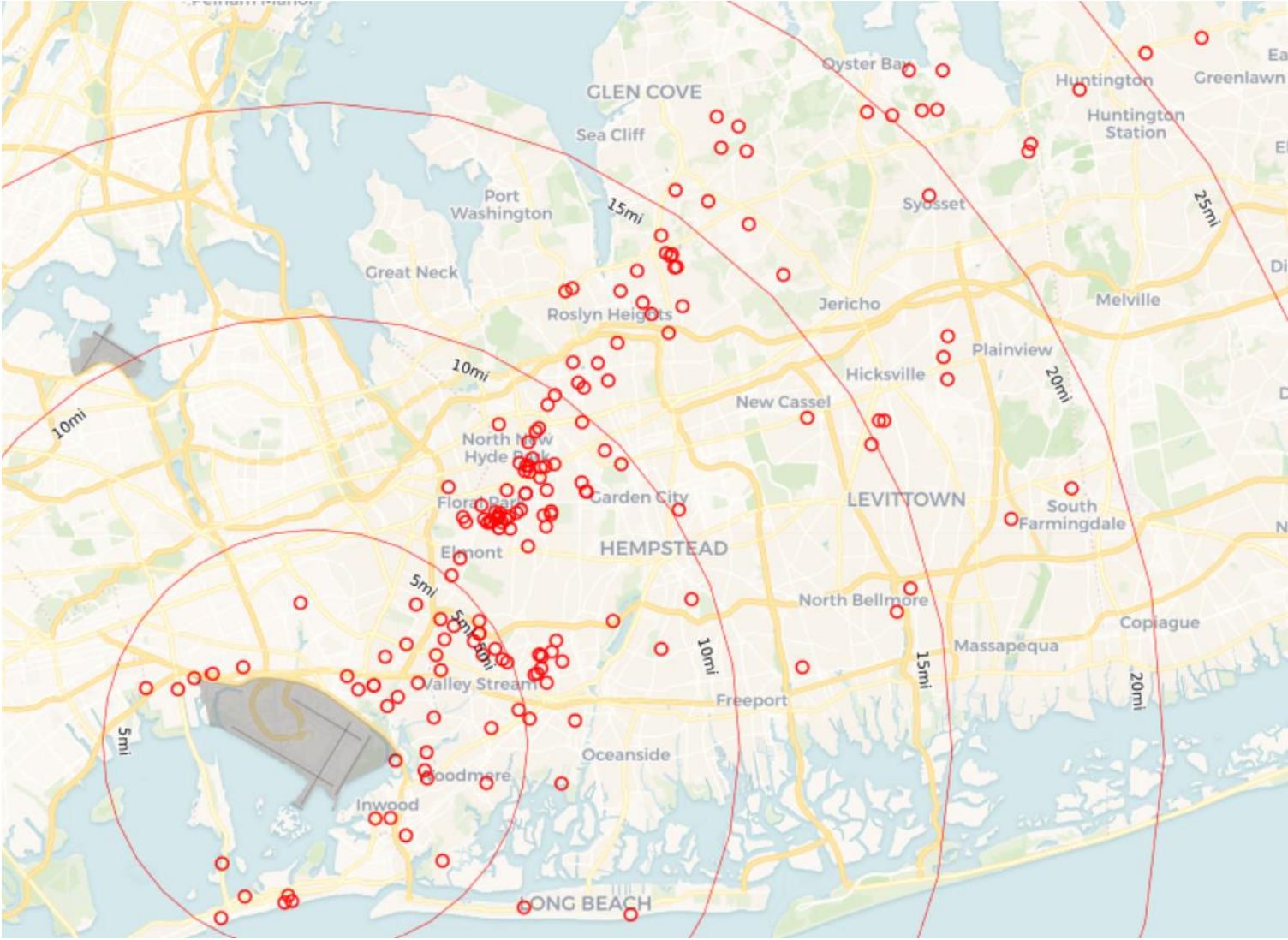

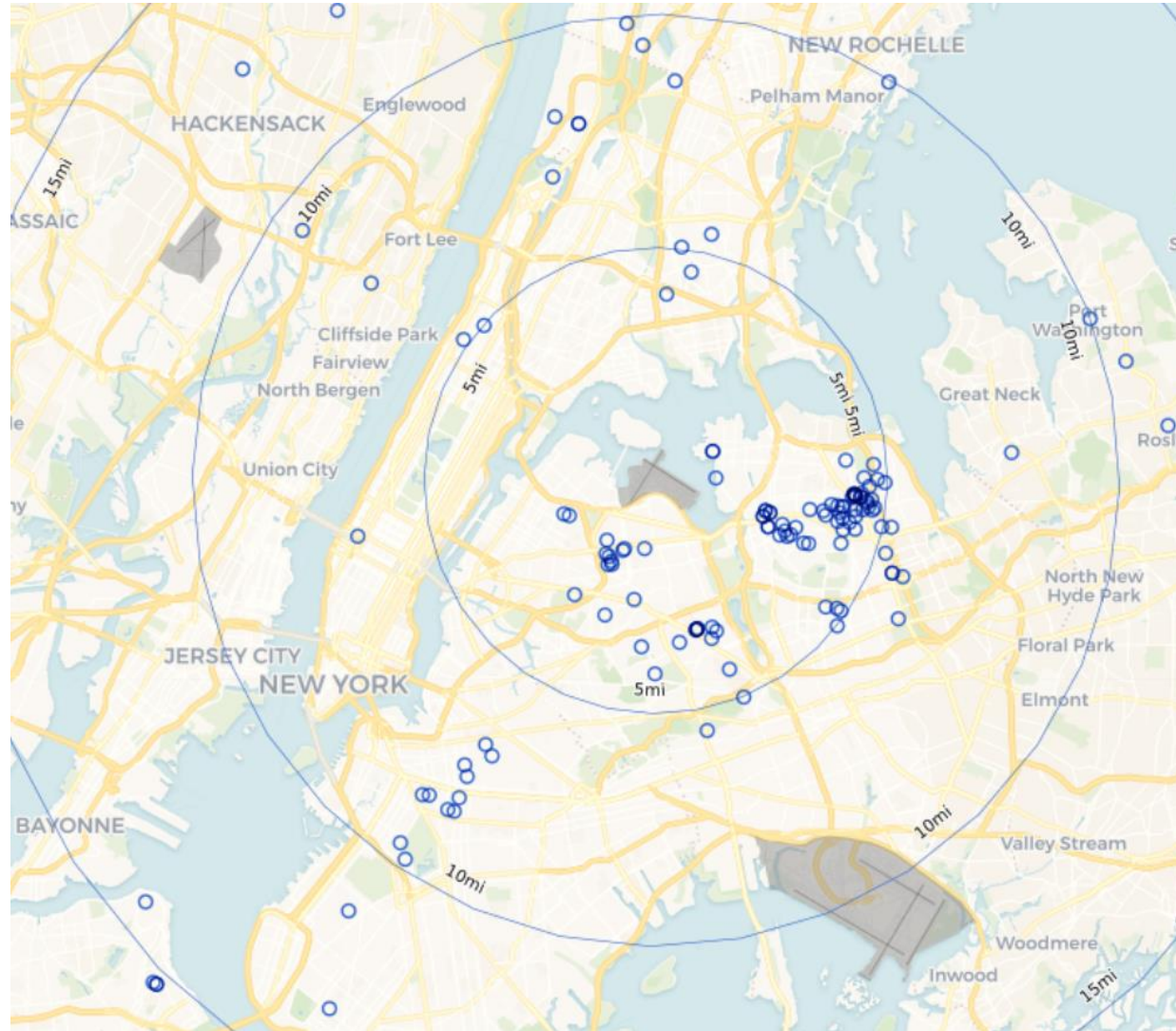
