

Number of Households by Airport - March 2020








Number of Complaints by Airport – March 2020




Noise Complaints Received Via Third-Party App(s)

- 3. While in the same database, data is compiled and reported a) for each individual noise complaint source, and, b) as a combination of all complaint sources.




Third-Party App Households Locations, by City* –March 2020






March 2020 JFK Households Location Map (PA PlaneNoise & Third-Party App)
