TANAAC was established on February 26, 1987

The main purpose of the committee is to establish a meaningful dialogue between the airport community and the residential communities.

The primary goal was to enhance the quality of life of the residents of local communities while insuring the efficient operation of the airport.

TANAAC is Comprised of:

- Locally Elected Officials:
 - Mayors (or a duly appointed alternate), State Assembly & Senate Members, and Members of Congress
- Bergen County Executive and Freeholder Chairperson
- Members of the Aviation Community
- Airport Manager FAA Tower Manager
- Fixed Base Operators and Heads of Corporate Flight Departments

One vote per member with the exception of the Airport Manager who will only vote in the case of a tie.

The general public may attend as observers of the proceedings.

Noise Abatement Rules

Maximum Noise Levels:

Runway 24:

- 80 dB(A) Between the hours of 2200L and 0700L
- 90 dB(A) Between the hours of 0700L and 2200L

Runway 01, 06, & 19:

95 dB(A) All Hours


Helicopter Departure Routes:

95 dB(A) All Hours

If a departure from Teterboro Airport exceeds the Maximum Noise Level associated with the runway used for departure, a violation shall be issued to the owner of the aircraft.

First and Second violations shall be kept for two years (from the date of the violation); upon the violations' second anniversary, it will be downgraded or expunged.

<u>A Third Violation</u> within a two-year period results in the permanent banishment of that aircraft from future operation at Teterboro Airport.





RNAV (GPS) X Runway 19 Outreach to Airport Users

- FAA published a Letter to Airmen on June 21 advising pilots of new alternate approach
- NBAA published an article titled "Pilots Encouraged to Request RNAV X Approach for TEB Night Ops". Article was sent to over 11,000 members.
- Teterboro Users Group (TUG) has posted updates on the procedure's implementation as well as best practice guidance on their website and mailing list.
- Approach information was posted on the TEB Noise Office website.
- The TEB Noise Office distributed a bulletin with detailed approach information to over 5,000 aircraft operators.
- The TEB Noise Office updated the Flight Crew Handbook publication and mobile app to include the new approach procedure.
- A note about the availability of the new approach is included in landing fee invoices.
- TUG discussed the approach at their September 15th member meeting.




Flight activity at TEB has begun to rebound from record low levels in 2020

- Runway 19 arrival usage was above average between June 2021 and September 2021
 - Runway 19 2020 annual arrival usage: 52%
 - Runway 19 arrival usage June September 2021: 72%
- Increased arrival usage of Runway 19 due to weather and extended closure of Newark Liberty International Airport (EWR) Runway 4R/22L for construction. To reduce delays at EWR, Air Traffic Control operated in a "south flow" configuration as often as possible.
- Due to airspace overlap, TEB air traffic must operate in the same configuration as EWR, i.e., flights must depart and arrive in the same direction at both airports.
- EWR Runway 4R/22L was reopened September 27th. This runway will be closed on weeknights and during weekends through April 2022.


January – September 2021






Noise Complaints January – September 2021





Noise Complaints: Nature of Disturbance January – September 2021




