Question #1: How are "staff members" defined? Must they be W2 type employees, which implies that the employer is obligated to establish a payroll process that includes deducting and paying such things as FICA and taxes directly on behalf of the employee; or, alternatively, may the staff members be 1099 employees, which places all obligations for the payment of typical payroll deductions on the employee rather than the employer?

Answer #1: Staff are defined as any members directly employed by the firm, as a W2 employee.
