The following are questions from RFP recipients. The questions and the corresponding Authority answers are provided for your information and use, as appropriate.

Question #1: Is the Authority able to provide the list of the subject RFP’s attendees?

Answer #1: The Authority has attached subject Pre-proposal meeting’s sign-in sheet for your reference.

Question #2: Are proposers required to name which MBE or WBE firms they plan to utilize under the Call-In program?

Answer #2: As per Letter I in Section III. of the RFP Letter, the selected Consultant(s) shall submit to the Authority for review and approval prior to commencing any services, along with invoices, the Statement of Subcontractor Payments in the form of the MBE/WBE Participation Report (Form PA 3760C) for each Task Order to perform work.

For the purposes of this RFP, provide the names and addresses of all MBE/WBEs that shall be included in the Plan. If none are identified, describe the process for selecting participant firms in order to achieve the good faith goals under this Agreement. If possible, indicate the percentage of MBE/WBE participation expected to be achieved with the arrangement described in the Plan, and describe the specific scope of work the MBE/WBEs will perform.

Question #3: Will the Authority be creating six total Call-In lists (three categories for SBE, three categories for non-SBE)?

Answer #3: Yes, this is the intent. Firms planning to submit a proposal for more than one of the categories must submit a separate, complete proposal for each category.
