The Port Authority of New York and New Jersey (the Authority) hereby amends the subject Request for Proposal (RFP), dated October 24, 2018.

- 1) Please note the date for receipt of proposals for the subject RFP has been changed to 2:00 P.M. on December 13, 2018.
- 2) In Section I PROPOSER REQUIREMENTS Delete Proposer Requirement C and replace with new Proposer Requirement C below.
 - "Firms shall have a minimum of fifteen (15) engineers on staff with a minimum of five (5) for Civil Engineering and five (5) for Structural Engineering as well as professional staff familiar with all design disciplines."
- 3) Delete Attachment G1 for Proposer Requirement A and replace with new Attachment G1 for Proposer Requirement A, revised 11/15/18.
- 4) Delete Attachment G1 for Proposer Requirement C and replace with new Attachment G1 for Proposer Requirement C, revised 11/15/18.
- 5) Delete Attachment G1 for Proposer Requirement D and replace with new Attachment G1 for Proposer Requirement D, revised 11/15/18.
- 6) In Section III PROPOSAL SUBMISSION REQUIREMENTS Delete item E.5 and replace with new E.5 below.
 - E.5 Identify subconsultants (i.e. geotechnical), if any, and indicate their experience and qualifications.
- 7) The following questions were received from a Request for Proposals (RFP) recipients(s). The questions and the corresponding Authority answers are provided for your information and use, as appropriate.

Question 1: We were wondering if the Principal-in-Charge for this contract must be licensed in both New Jersey and New York or is the Authority looking for us to list the Partners/Principals of the firm, whether proposed or not, as part of the Proposer Requirement?

Answer 1: The requirement for licensure in New York and New Jersey can be met by multiple persons. i.e. – 1 principal for New York and 1 principal for New Jersey. List the Principals of the firm, whether proposed or not. Refer to section I – B Proposer Requirements in the RFP Letter.

Question 2: Firms shall have a minimum of ten (10) engineers with experience in each of the following areas of engineering: Civil Engineering, Structural Engineering, and Geotechnical Engineering as well as professional staff familiar with all design disciplines" can you please confirm the requirement is for 10 engineers total or if the requirement is for 10 individual civil engineers, 10 individual structural engineers, and 10 geotechnical engineers for a total of 30 engineers.

Answer 2: See item 2) above.

Question 3: In our response to section H Financial Information, item 3 Statement of Work, can we submit only projects or do proposals have to be included as well?

Answer 3: Refer to Section III, item H (3) - which states "including any work on which a bid and/or Proposal has been submitted".

Question 4: Regarding Attachment G-1, Proposer Requirements C and Requirements D, please clarify what information you are looking for is the section "Brief description of Scope of work" for the individuals listed. Do resumes need to be provided for the individuals listed on the forms if they are not listed as "key staff"?

Answer 4: Forms G1 for Proposal Requirements C and D have been revised under this Addendum. Resumes are only required for key personnel at this time.

Question 5: Please clarify which of the following forms need to be submitted by the subconsultants:

In addition to the forms that need to be submitted by both Consultants and their subconsultants/subcontractors, several of the certifications require Consultants to include provisions in their subcontracts, and obtain certifications from their contractors, and in that case the Proposer should submit such forms/certifications from their known subconsultants/subcontractors at the time of proposal submission.

Question 6: Considering that a number of RFPs have been recently issued by the Authority and the upcoming Thanksgiving holiday, we respectfully request an extension until December 14, so that we may better respond to the information requested.

Answer 6: See item 1) above.

Question 7: The subject RFP has a minimum Proposal Requirement for 10 Geotechnical Engineers from the Prime. Please consider allowing the geotechnical requirement to be met through utilizing subconsultants.

Answer 7: The Authority will allow subconsultants to be proposed as the Geotechnical lead(s). See item 2) above.

Question 8: Are subconsultants required to submit the M/W/DBE forms at this time?

Answer 8: No
