Dear Sir or Madam:

The Port Authority of New York and New Jersey (the Authority) hereby amends the subject Request for Proposals (RFP), dated August 27, 2019, as follows:

1) In the standard Agreement, under Section 20., include the following after the last paragraph:

## **Diversity of Staff Proposed in response to Task Orders:**

The Port Authority expects that the proposer's team and workforce reflect that full diversity of the community that the Port Authority serves. As such, the Consultant shall propose subconsultants for the team and staff on Task Order responses under this Agreement to reflect this diversity. All staff will be subject to the approval of Authority.

The Consultant shall be required to demonstrate that a diverse pool of individuals, and Firms that are certified as MBE or WBE have been solicited to fill meaningful, core positions and perform services under this Agreement.

## **Update to Subconsultant Language regarding MBE/WBE Goals:**

The Port Authority expects that the proposer's team and workforce reflect the diversity of the community that the Port Authority serves. The Authority has set a goal of twenty percent (20%) participation by qualified and Authority certified MBEs and ten percent (10%) for qualified and Authority certified WBEs on technical service projects. Subconsultants shall be used in a manner that results in them receiving core and meaningful work, and encourages subcontracting for substantive positions. Said firms which are included to meet the above stated goals must be shown to demonstrate diversity in positions of importance, and/or perform functions of importance.

## **Local Employment Opportunity**

The Port Authority is committed to making employment opportunities available to local residents and has identified resources for the Consultant such as the the Council for Airport Opportunity (CAO) to utilize the labor talent available from local communities surrounding the Airport. For purposes of this section, a "**local resident**" is defined as a natural person residing within Queens in the State of New York.
