Hand deliveries and mailed deliveries (e.g., UPS, USPS) will not be accepted. The Port Authority may request an original, signed paper submission at any time following the Response Due Date. If requested, such original, signed paper submission must be

identical to the electronic submission. In the event of a discrepancy, the electronic submission shall control.
