BRIEF DESCRIPTION: The Port Authority accesses Bloomberg L.P.'s interactive financial information network to instantly communicate directly with the largest, secure network of portfolio management broker/dealers. The service displays live transactions in the U.S. Treasury securities market, information on money markets, futures markets, stock markets, corporate and municipal bond markets, and other market services.

The Bloomberg network is the standard for all financial institutions with which the Port Authority conducts business. The services provided include real-time and archived access to financial and market data that aids staff in making decisions that could minimize the Port Authority's risk of financial loss and maximize opportunities to increase revenues. The service displays live transactions in the U.S. Treasury securities market, information on money markets, futures markets, stock markets, corporate and municipal bond markets, and other market services.
