NOTICE OF INTENT TO SOLE SOURCE

The Port Authority of New York and New Jersey (PANYNJ) intends to establish a sole source contract with **Idemia Identity & Security USA LLC**, located in Bedford, MA to provide the following:

SCOPE: Purchase, Integration and Maintenance and Support of IDEMIA Criminal and Civilian Livescan systems at multiple Port Authority Police Department (PAPD) commands located in New York and New Jersey.

BRIEF DESCRIPTION: PAPD has deployed Idemia Identity & Security USA LLC (Idemia) Livescan fingerprint systems throughout the Agency and these systems will require continued maintenance and support services. They will also need to be refreshed with new Idemia Livescan hardware as and when the corresponding hardware used by the New York Police Department and the New Jersey Police Department are refreshed. To ensure compatibility, to facilitate integration with the existing system, to reduce operation and maintenance costs, and to maintain single source maintenance responsibilities, it is necessary to retain service and acquire equipment from Idemia.

Firms who believe they can compete for this requirement are required to submit an email with a brief statement of their intent to compete.
