The Port Authority of New York and New Jersey (the “Authority”) is seeking to identify firms interested in responding to a Request for Proposals (RFP) for the performance of Expert Professional Disaster Response and Recovery, Storm Mitigation and Resilience, Insurance Adjustment, Grant Management and Grant Financial Reporting, Analysis and System Support Service on an “As-Needed” Basis during 2025 through 2029.
