Re: Freedom of Information Request

Dear Secretary Eastman:

We write this letter to request that Tutor Perini Civil Group and its counsel Locke Lord Bissell & Liddell LLP be allowed to inspect, or be provided with copies of, public records, documents or material of the Port Authority of New York and New Jersey (the "Port Authority"), pursuant to the Freedom of Information Policy and Procedure of the Port Authority, the New York Freedom of Information Law, and New Jersey's Open Public Records Act. The documents we request are related to the Request for Qualifications for the Goethals Bridge Replacement Project (RFQ # 22697) (the "RFQ"). Specifically, we request copies of the following documents, or documents sufficient to show the following:

1. Any and all Statements of Qualification ("SOQ") submitted to the Port Authority with respect to the RFQ.
2. Any and all written communications from the Port Authority to any team (or members from any team) which submitted an SOQ in response to the RFQ (the "Submitter" or "Submitters") related to the RFQ and/or the SOQ, including but not limited to any Requests for Clarification issued by the Port Authority to any Submitter.
3. Any and all written communication from any Submitter to the Port Authority, related to the RFQ and/or the SOQ, including but not limited to all responses to Requests for Clarification issued by the Port Authority to such Submitters.
4. The names, titles and addresses of each member of the Voting Committee of the Port Authority which reviewed the SOQ (the "Voting Committee").

5. Any and all documents related to the establishment of the Voting Committee and/or describing the Voting Committee's duties and responsibilities.
6. The names, titles and addresses of any Technical or Financial Expert, either retained by the Port Authority, or employed by the Port Authority, who reviewed the SOQ (the "Technical and Financial Experts").
7. Any and all documents related to the appointment or retention of the Technical and Financial Experts and/or describing the Technical and Financial Experts' duties and responsibilities.
8. Any and all documents, including correspondence, communications, written analysis, summary sheets, questions, or recommendations related to the SOQ or any Submitters, submitted or provided by the Technical and Financial Experts, to the Voting Committee.
9. Any and all documents, including correspondence and questions, related to the SOQ or any Submitters' communications with the Port Authority, sent by the Voting Committee, or any member thereof, to the Technical and Financial Experts.
10. Any and all documents created by the Voting Committee, or the Technical and Financial Experts related to the evaluation of the SOQs, and any Submitters subsequent communication with the Port Authority, including:
 - a. any evaluation forms prepared in accordance with Section 6.3 of the SOQ;
 - b. any documents evidencing the scoring of the individual SOQs submitted in accordance with Section 6.3 of the SOQ; and
 - c. any documents summarizing the scoring of the SOQs, in accordance with section 6.3 of the SOQ.
11. Any and all documents submitted by the Voting Committee or the Technical and Financial Experts to the Executive Director of the Port Authority, or the Board of Commissioners of the Port Authority, related to the SOQs.
12. Any and all documents submitted by the Executive Director of the Port Authority to the Board of Commissioners of the Port Authority, related to the SOQs.
13. Any and all documents, including correspondence, sent by the Executive Director of the Port Authority to the Voting Committee, or the members thereof, or the Technical and Financial Experts, or any thereof.

14. Any and all documents related to the Request for Information/RFI # 21273 ("RFI") dated May 2010 issued by the Port Authority, including all drafts, revisions, amendments and comments and responses received by the Port Authority in response to the RFI.

15. All Minutes of meetings of the Port Authority, or any of its committees or subgroups, relating to or concerning RFQ # 22697 and more generally the replacement of the Goethals bridge.
