Re: Freedom of Information Act Request

Dear FOIA Officer:

This is a request under the Freedom of Information Act.

Pursuant to the state open records act, I request access to and copies of New York and New Jersey state budget reports detailing the cash revenues generated by the Lincoln Tunnel for the period between Jan. 1, 2011 and Feb. 1, 2011.

I would like to receive the information in electronic format if possible.

In order to help determine my status to assess fees, you should know that I am a senior at Northwestern University in Evanston, Ill. As a result, this request is being made for a scholarly purpose and not for commercial use.

Please waive any applicable fees. I am requesting a waiver of all fees under N.Y. Pub. Off. Law § 86(2)(g). The information I seek is in the public interest because it will contribute significantly to public understanding of the operations or activities of the Port Authority of New York and New Jersey. Similarly, this information is not primarily in my commercial interest.

In the event that this request will result in any fees (for copying, searching, etc.), I would like to be notified before the request is filled. Additionally, if there is any fee for this request I would like to withdraw it completely.

If my request is denied in whole or part, I ask that you justify any and all deletions by reference to specific exemptions of the act.

In making this request, it is my hope that this information can be relayed in a timely fashion. For that reason I would appreciate communication with me by telephone, rather than by mail, if you have questions regarding this request.

I look forward to your reply within 20 business days, as the statute requires.


Dear Mr. Freifelder:
