- any and all agreements and/or contracts for work, performance, construction, demolition, renovation, repair, shutdowns, installation of equipment and/or materials, maintenance of premises, maintenance of equipment and/or materials, removal of equipment and/or materials, monitoring, assembly of equipment and/or materials;
- any and all agreements and/or contracts between general contractors and subcontractors and/or other contractors for work, performance, construction, demolition, renovation, repair, shutdowns, installation of equipment and/or materials, maintenance of premises, maintenance of equipment and/or materials, removal of equipment and/or materials, monitoring, assembly of equipment and/or materials;
- work applications, work licenses, work tickets, time sheets, work orders, work permits, building permits, any and all other required permits/approvals, complaints, construction/repair records;
- invoices, receipts, bills of sale, contracts, business agreements or other documentation relating to the costs, sale, distribution, delivery, installation, repair, rebranding, or authorization for maintenance of any products, equipment, and/or machinery on the Premises;

- any and all citations and/or violations received for any asbestos-related violation on the Premises, including but not limited to OSHA and any state's Division of Labor.


I understand there is a fee of \$.25 per page for duplication of the records requested.
