Information provided by LH Manager Madhu Chadha:

At approximately 15:07, LH Manager Madhu Chadha (ID # 6440472659) requested a Supervisor at gate # 5 departures. The LH Manager reported that a LH 401 crew member, Mrs. Elizabeth Stephan- Breemer (ID # PK- 071306G) stated that she had slipped and fallen due to a coffee spill in front of the CTX Machine near the LH first class ticket counter and hit her left knee.

Mrs. Stephan-Breemer refused further medical attention and proceeded to board the aircraft. This incident was witnessed by LH Supervisors Patrick Leroy (ID # 6440494602) and Jutta Mazzanti (ID # 6440503388).


No visible inspection of the area was conducted as this report was provided after the incident had occurred.
