

Board Meeting

December 10, 2014

Airport Employee Parking

→ **Dedicated Employee Parking Lots**

- Connected to Central Terminal Area via shuttle bus or AirTrain
- 22,400 employees
- \$50/month (since 2006)
- Net expense: \$1.1 million/year

→ **Central Terminal Area Public Parking Lots**

- Premium parking adjacent to passenger terminals
- 7,000 employees
- \$50-\$150/month (since 2006)
- CBP employees pay \$25/month
