Please be advised that we represent TIMOTHY FOUCHER in a personal injury litigation arising from an accident on 3/6/2015 at LaGuardia Airport, Runway 13, Queens, New York, regarding the removal of Delta Aircraft that ran off the runway on March 5, 2015 as well as the repair of the subject runway.

Pursuant to Article 8 of the Public Officers Law, known as the Freedom of Information Law, we hereby request that you provide us with the following information and documents:

- Photocopies of all records, including but not limited to accident reports, incident reports, medical records, witness statements and any and all other documentation related to the above accident;

- All contracts for work performed regarding the repair of the Delta Aircraft;
- All contracts for work performed regarding the removal of the Delta Aircraft from the runway;

- Any and all video and photographs portraying the entire operations regarding removal of the Delta Aircraft;
- Any weather and/or wind reports for March 5, 2015 and March 6, 2015;
- Any other documents, records and/or reports relating to the process, procedure and/or operations employed regarding the repair of the subject runway and/or removal of the Delta Aircraft.


Dear Ms. Peebles:
