Saturday August 8 at 1130pm to Sunday August 9 1am at the toll plaza on the Goethals Bridge before the train bridge I Salman Khan was involved in an accident. Joseph Goodwin was heading eastbound towards the toll plaza. Goodwin made the illegal U turn onto the westbound traffic lanes and from behind the divider wall into our westbound traffic lanes. I tried to avoid by turning hard right and made contact with his 2007 purple scion tc 2dr coupe with my 1998 blue ford explorer right side. we called 911 but no one showed up. Goodwin only wanted to exchange only insurance information and did not want to give any other information. my wife and I amd Goodwin waited for about 45 minutes to almost 1 hour for police. Then we all left. Later Goodwin retracted his story and said he was travelling westbound already and hit him changing lanes. I am requesting the video of the westbound lanes for that time and night so I fight the case, because they are blaming me for the accident. Thank you Salman.
